Original Documents to be Submitted / Shown at the time of Admission:

- a. **Original Marks Card of S.S.L.C and all the Years of Bachelor Degree** (i.e., I, II and III Year / All Semester Marks Cards of B.A /B.Sc /B.Com /B.B.M /M.B.B.S /B.E /B.L /B.Pharm /B.Sc Agri. etc.,) Candidates are required to submit the relevant Original Marks Cards along with a set of attested photo copies. **Original Marks Cards will be sent back/given to you immediately after the verification. If Original Marks Cards are not submitted/shown at the time of admission such Admission will be cancelled.**
- b. **Two recent Passport Size and Two Stamp Size Photographs.**
- c. **Caste / Income Certificates (SC/ST, OBC)**if admission is sought under any reservation category (**Applicable to students of Karnataka State Only**).
- d. **Original Transfer Certificate** of the College/University/Institute in which the candidate attended last. If TC is not given by the college, a prescribed format will be issued to the students by the Department at the time of enrolment. This will help the institute in which you have attended last to process and dispatch your TC to the University.

Candidates who have passed Bachelor's Degree with less than 50% and **three years experience** at supervisory / managerial / professional. (Such candidates should have completed 3 years of service as on your online CET Application. After completion of degree). **In Service candidates means working in public sector, large / medium private sector, MNCs and SSI only.** Candidates working in petty shops, auditors, tax consultants, office boys, contractors, medical shops, provision stores are not eligible to apply.

1. If the documents are not received on or before the date mentioned above, your selection will be cancelled without any further intimation to you. **Candidates are advised to preserve the admission intimation letter and produce it whenever the University demands it.**
2. **The study materials for First Year MBA (1st and 2nd Semester) will be issued In-Person on completion of admission.** Arrangement will be made to dispatch study materials to the out stationed students after completion of admission.
3. No correspondence is entertained with regard to admission.
4. **Admission for MBA Programme (In-House) is at admission Section, Karnataka State Open University, Mukthagangotri, Mysore and the regional centres.**
5. **The Karnataka State Open University has not authorized any other Institute/Study Centres to admit the candidates for MBA (In-House) Programme.**
