 - (f) Rates for supply of partial quantity of an item are not acceptable.

4. Evaluation of quotations

 - (b) The evaluation would be done for all the items put together. The items for which no rated have been quoted would be treated as Zero and the total amount would be computer accordingly. Purchaser will award the contract to the responsive tenderer, whose total cost for all the items put together is the lowest.

 - (a) The purchaser will be award the contract to the tenderer whose quotation has been determined to be substantially responsible and who has offered the lowest price as per para 4 (b) above.
 - (b) The purchaser reserve the right at the time of contract award to increase or decrease the quantities of any or all of the items indicated in Para I 25% without any change in the unit price or any terms and conditions.
 - (c) Normal commercial warranty/guarantee if available shall be applicable to the supplied goods;
 - (d) Payment shall be made after the delivery of the goods and their acceptance.
 - (e) Notwithstanding the above, the purchaser reserves the right to accept or reject any quotations and to cancel the quotation process and reject all quotations at any time prior to the award of the contract.
